Water Technician Report:

- > Update on Hunt Engineers on Grant applications we continue to work with them on the process.

Fire Council: Fire Chiefs Report reported by John May. He reports the following: EMS-14 calls, MVA-2, Good Intent-1, Service-3, Outside Fire – 1, Structure Fire-1 for a total of 22 calls. Resolution for Budget Amendment to cover past due bills not submitted by former Chief. A motion was made by Damon and seconded by Yontz that for the 2023/2024 Budget the revenue Acct. line "Fund Balance" be increased in the amount of \$5,290 (the new total is \$4,4672) and the Appropriation Acct A522/3410.4 "Fire Department Contractual" be increased in the same amount (new total\$224,230) to cover prior year expenditures not submitted by the former Fire Chief.
